Maternal grandmother does provide childcare from time to time. Mother and father have been together since high school but are not married. Both parents have a high school diploma. Neither parent have any legal history. The family is heavily involved in the local church. They live in a rural town and own the home.

Patient and family engaged in behavioral health services and met with a BHC same day as primary care appointment. BHC met with family and scheduled a follow-up appointment within a week. Family was brought back in, and it was identified that pt struggles with boundaries and eating nonfood items. Mother reported that pt was eating all kinds of items all times of days. Mother and pt presented to appointments and follow-ups jointly. In total mother and pt presented to 4 appointments.

Barriers to Treatment

Mother reported that finding childcare for the other child and transportation due to location of home and hospital was stressful. During treatment it was noted that mother struggled with both children and being the sole caretaker during the day. Mother reported that monitoring pt and sibling while making meals was difficult. Mother reported that father works 4–10-hour shifts and was often gone before the children wake up and not back before bed. Mother reported that maternal grandmother lives over 2 hours away which makes getting support difficult and she is unable to drive.
